What is a network of High Performing Skilled Nursing Facilities?

- Trinity Health and their Clinically Integrated Networks (CIN) developed a High Performing Providers Network of Skilled Nursing Facilities.

Are these facilities certified?

- Skilled and sub-acute facilities are certified by the state and federal government agencies to provide levels of care that range from custodial care to skilled nursing that can only be delivered by trained professionals.

What is Michigan Clinically Integrated Network?

- We are a physician-led organization focused on improving the quality of care and our patients' experience and delivering care at an appropriate cost. How does a Skilled Nursing Facility become a High Performing Skilled Nursing Facility?

- Statewide criteria for High Performing Skilled Nursing Facilities include the following: Attendance at quarterly regional meetings, Quarterly data submission with the focus on quality metrics, CMS 5-Star quality rating and participation in hospital-based programs such as SEPSIS, COPD and Heart Failure.

What is the meaning of a "High Performing Skilled Nursing Facility" status?

- High Performing Status indicates that a Skilled Nursing Facility meets all our requirements and is or will be listed as a High Performing SNF Provider on our network's High Performing Skilled Nursing Facility Provider List.

How often are the criteria reviewed and applied?

- We review our criteria on a quarterly basis and update our list of a high performing Skilled Nursing Facilities accordingly.

Is a hospital responsible for providing a list of High Performing Skilled Nursing Facilities to their patients?

- Yes, it is our responsibility to assist you in choosing a quality provider for your next level of care.
